#### 7. New Business

Presentation by Mike Meidel, Director, Pinellas County Economic Development

Mr. Meidel gave an overview of what the Pinellas County Economic Development Department is doing to create more money flowing into the county economy. Although tourism is an important part of economic development, the downside to the tourism industry is that the hospitality, housekeeping and wait services have lower wage levels. Tourism is only 20 % of the local economy. The biggest part of the remaining 80% is healthcare and related services.

Mr. Meidel stated it was their goal to identify and encourage companies, such as financial institutions, I.T services, manufacturing, and the defense industry, all of which will result in higher wages and the construction of hotels, the manufacturing of service products and other types of development which create jobs. A wide diversity of companies keeps our economy strong.

The PCED talks with companies every day to help them succeed and works directly with them to identify their expansion plans and needs. It promotes programs and classes on how to run a small business, including accounting, marketing, web and social media, identifying customers and export development. The PCED also works closely with the Chamber of Commerce to encourage manufacturers to buy from local suppliers. Many local small companies create components for larger firms, such as medical supplies and devices, and those on the leading edge of scientific products.

Help is available to get through regulatory processes and incentives are offered based on jobs created, wage levels and taxes paid into the economy. Help is provided navigating through the permitting process, local requirements, zoning inspections, and other types of obstacles, resulting in expediting construction of new facilities.

Mr. Meidel stressed that light rail is the best method to accommodate retail, while not clogging traffic. It's also critical to create non-stop express highways.
