# 3. Approval of Agenda

**Mayor Soranno** amended the agenda by removing the November 2019 Treasurer's Report as it was not ready. Motion was made and duly seconded to approve the agenda as amended. The motion carried unanimously.

# 4. Approval of Minutes

• Minutes for the October 30, 2019 BIG C Meeting at the City of Belleair Beach.

Mayor Queen moved to approve the meeting minutes of October 30, 2019. The motion was duly seconded by Mayor Kennedy and the motion carried unanimously.

# 5. Approval of the October and November 2019 Treasurer's Report.

Mayor Henderson reported that the opening and closing balance for October was \$1,071.88.

**Mayor Queen** moved to approve the October 2019 Treasurer's Report, and duly seconded by **Mayor Johnson**. The motion carried unanimously.

## 6. Correspondence

• Email from Coastal Management Coordinator of Pinellas County, John Bishop, sharing a Perpetual Storm Damage Reduction Easement template.

There were no comments on the correspondence.

#### 7. New Business

- Florida Shore & Beach Preservation Association (FSBPA) President, Pepper Uchino, to discuss:
  - o Technology available to slow down or prevent shore erosion
  - o Customary use vs. beach easements issues

Mr. Uchino mentioned that sea level rise, weather events, red tide and blue-green algae blooms are fundamental issues for the beaches. He mentioned the FSBPA Tech Conference at the Hyatt in Sarasota, February 5-7, 2020, for those interested in learning more about the issues facing Florida shores and waters.

There are not a lot of innovative methods that yield results when dealing with shore erosion. Those that have yielded results were cost-ineffective when applied to a larger scale. Hardening structures, proper beach design and construction works with proper supports for dune structures that can withstand forces that cause beach erosion. Drone technology can help to survey beaches. Sand plantings also help at a smaller scale. The last resort would be seawalls and other types of armoring to protect structures.

Mr. Uchino briefly touched on the process of beach funding that is received from the Federal Government. He also noted that funds allocated for a project that is not completed may be re-allocated for another project.

In 2018 the Florida legislature passed a bill approving customary use. The four customary use elements used by courts to determine the use are: Is the use ancient, is it reasonable, is it without interruption, and is it free from dispute?

He proceeded to speak on easements stating that it is fundamentally different than customary use. An easement is a non-possessory property right. It is a use right. Courts address perpetual easements. Ways easements are extinguished include reaching their expire date or their time limit, a release from the Army Corps of Engineers, and the third is abandonment where no action has been taken to legitimize the easement's existence.

Conversation ensued regarding beach erosion prevention and easements.

#### 9. Miscellaneous

**John Bishop** mentioned the Redington Shores Easement Meeting that was held on November 14. The video will be posted on Pinellas County's website soon for those who wish to view the meeting. Thirty-one signed easements have been received since May. They are still working on verifying addresses for Indian shores. They are also planning on future meetings for Indian Shores and Indian Rocks Beach in January and February.

**Sandra Knoebel** brought traffic, personal, mile marker, and trail maps for those would like to make them available for the public.

**Bob Griffin** mentioned the billboards in Indian Rocks Beach. They are paid for by citizens, businesses, and organizations. Anyone interested in the billboards can contact him.

An audience member mentioned there was a meeting at Indian Rocks Beach with the Florida Fish and Wildlife Conservation Commission (FWC) regarding coyotes.

## 10. Legislative Update

Senator Jeff Brandes mentioned that the Legislative Session will start in January and advised everyone to submit their appropriations. This year, there is not a lot of discretionary dollars that are going to be spent. A significant portion of the budget will be allocated for increasing teachers' salaries. Another large portion will be allocated for environmental funding. Affordable housing and transportation continue to be consistent issues due to population growth. There is a push for more affordable housing. The increase in insurance litigation costs is another concern as insurance rates for the state of Florida could increase 15% to 20% over the next two years. Senator Brandes also touched on the unemployment rate of 3.5%.

Mayor Soranno asked for a status on the private insurers that were encouraged to enter the flood insurance market.

**Senator Brandes** thinks that 85% of the policies written in Florida could be written at a lower rate in the private market. Policies for heavily subsidized areas such as the beaches continue to be a challenge.

Legislative Assistants Neisha-Rose Hines and Jessica Lewis provided their updates from the Office of Representative Jennifer Webb.
