3. Changes to Agenda and Approval

Mayor Schear made a motion to approve the agenda. Mayor Doctor seconded the motion. Motion approved unanimously.

4. Approval of Minutes of Redington Shores January 29th, 2025 Meeting

Mayor Brooks made a motion to approve the January minutes. Mayor Hendrickson seconded the motion. Motion approved unanimously.

5. Approval of January 2025 Treasurer's Report

Mayor Hendrickson reported the current balance of \$1100.44. Mayor Rector made a motion to approve the treasurer report. The motion was seconded by Mayor Houseberg. Motion approved unanimously.

6. Correspondence

There was no correspondence.

7. New Business

Commissioner Scott spoke regarding the CDBG-DR Action Plan process and the need to get money into people's hands in a timely fashion. He introduced the consultants from HORNE, Ryan Flannery and Jenna Abbey who has been hired to navigate the block grant program for the County.

Mr. Flannery and Ms. Abbey gave a brief background on themselves and Horne. They presented slides detailing the process for the HUD CDBG-DR grant. The grant is a Community Development Block Grant Disaster Recovery grant. They stated the program began in 1993 with Hurricane Andrew and has grown into its current form. They describe the program as flexible but compliance is challenging.

They broke down the amount available and the distribution percentages. Of the total grant, which is \$813 million, \$707 million will go for unmet disaster recovery needs and the remaining \$106 million to mitigation projects. They added that 70% of the funds must go to low to middle income households which in Pinellas is \$76,000 for a family of four.

Mr. Flannery and Ms. Abbey stated they are now in the planning stages and as there are various steps to implement it, they expect the agreement to be presented to the County Commission in the third quarter of this year.

Mike Twitty, Pinellas County Property Appraiser, spoke regarding processes implemented by his office to help with storm recovery. The processes include the ability to apply for a partial tax refund when certain qualifications are met, a revaluation process for those who disagree with their building value, a trust verification letter for those properties that are held in trust but want to pull a owner/builder permit and information on how to keep your homestead exemption when your property is demolished.

9. Discussion Items (out of order)

Mayor Gattis moved discussion items up due to a board member needing to leave early. There was no discussion items from the Board, however Mayor Gattis had two items:

- He stated the letters regarding storm recovery and beach renourishment had been sent to the President and would arrive on Thursday. He added that Rep. Luna had immediately forwarded a digital copy.
- Mayor Gattis read a letter of appreciation for Mayor Bill Queen, congratulating him on his retirement. The Board also presented a glass fish sculpture in appreciation for his two decades of serving on the BIG C.

New Business Resumes

Ryan Chatman, of Forward Pinellas, spoke regarding the multimodal impact fee. He explained how the fee is applied, based on new development. He went over the current fee schedule for Pinellas County compared to neighboring counties, showing Pinellas' fee is considerably lower.

Mr. Chatman went over how the fees are distributed and the various projects that have been funded by the funds. He indicated they would be meeting with the County Commissioners in the coming months for direction how to move forward.

10. Unfinished Business

There was no unfinished business.

11. Legislative Update

There were no legislative updates.
